
Subject: Estimation of production for non - reporting units - regarding

It has been observed during scrutiny that the data sent by various source agencies for the compilation of all India - Index of Industrial Production suffers from the problem of non response from a considerable number of units and the source agencies are not following uniform procedure for estimation of production for non-responding units. Sometimes, abnormal variations have been observed in the monthly production data due to this.

Source agencies are, therefore, requested to estimate the production figures for the non-responding units by applying any one of the following methods:

1. Previous month's production figure of the particular unit
2. Previous year same month's production figure of the particular unit
3. Average of the last 3 months' production figures of the particular unit.

At the time of furnishing production data every month, source agencies may please be indicate which of the aforesaid methods has been adopted for estimation of production of non-responding units.
