## Major initiatives and achievements of the Ministry of Statistics & Programme Implementation during July 2019

On the Statistics side, the Ministry has released monthly Index of Industrial Production (IIP) and the Consumer Price Index (CPI). The salient features of these are:

- As per the Quick Estimates (QE) of Index of Industrial Production (IIP) with base year 2011-12 released on 12<sup>th</sup> July 2019, the general index for the month of May 2019 stood at 133.6, which is 3.1% higher as compared to the level in the corresponding month of previous year.
- The General Consumer Price Indices (CPI) with base year 2012 for the month of June 2019 (provisional) for Rural, Urban and Combined showed an annual inflation rate of 2.21%, 4.33% and 3.18% respectively. The Consumer Food Price Indices (CFPI) for June 2019 (provisional) for Rural, Urban and Combined showed an annual inflation rate of 0.43%, 5.56% and 2.17%respectively.
- 2. The Ministry has notified Code of Ethics for Members of the various Committees constituted by MoSPI or by the Organizations, Institutions and bodies etc., funded by it. The notification was issued on Gazette of India on 19<sup>th</sup> July 2019. The Code aims to set out certain standards of conduct for the members of the Committee in order to protect the confidentiality of the data/information acquired by them by virtue of their membership in such Committee.
- 3. Monitoring of the infrastructure sector highlighted the following:

- As per the latest Review Report on the Performance of the Infrastructure Sectors for the month of May 2019, Power Generation (+6.66%), Refinery Production (+1.61%), Upgradation of Highways by State PWD & Border Road Organisation (BRO) (+21.56%) and Goods traffic carried by Railways (+0.15%), exceeded their targets.
- The Sectors that fell short of their targets are Coal Production (-13.37%), Fertilizers Production (-16.81%), Crude Oil Production (-1.92%), Natural Gas Production (-4.56%), Upgradation of Highways by NHAI (-0.38%), Export Cargo handled at Airports (-2.98%), Import Cargo handled at Airports (-14.75%), Passenger traffic handled at International terminal of the Airports (-7.35%) and Passenger traffic handled at Domestic terminal of the Airports (-12.87%).
- 4. Under MPLADS, an amount of ₹285.00 crore have been released during the Month of July 2019 and the total fund released during the financial year 2019-20 up to 31<sup>st</sup> July 2019 is ₹687.50 crore.
