



Major initiatives and achievements of the Ministry of Statistics & Programme Implementation during January 2020

The National Statistical Office (NSO) has released monthly Index of Industrial Production (IIP) and the Consumer Price Index (CPI). The salient features of these indices are:

- As per the Quick Estimates (QE) of Index of Industrial Production (IIP) with base year 2011-12 released on 10th January 2020, the general index for the month of November 2019 stood at 128.4, which is 1.8% higher as compared to the level in the corresponding month of previous year.
- The General Consumer Price Indices (CPI) with base year 2012 for the month of December 2019 (provisional) for Rural, Urban and Combined showed an annual inflation rate of 7.26%, 7.46% and 7.35% respectively. The Consumer Food Price Indices (CFPI) for December 2019 (provisional) for Rural, Urban and Combined showed an annual inflation rate of 12.97%, 16.12% and 14.12% respectively.

2. Field work of 7th Economic Census has been launched in the State of Gujarat during January 2020, taking the total tally to 30 States/UTs so far. Field work in remaining States/UTs will be launched shortly.

3. Monitoring of the infrastructure sector highlighted the following:

- As per the latest Review Report on the Performance of the Infrastructure Sectors for the month of November 2019, Power Generation **(+5.17%)** and Refinery Production **(+0.93%)** exceeded its targets.
- The Sectors that fell short of their targets are Coal Production **(-17.03%)**, Fertilizers Production **(-15.02%)**, Crude Oil Production **(-5.35%)**, Natural Gas Production **(-6.40%)**, Upgradation of Highways by NHAI **(-10.34%)**, Upgradation of Highways by State PWD & Border Road Organisation (BRO) **(-0.12%)** Goods traffic carried by Railways **(-4.98%)**, **Export** Cargo handled at Airports **(-5.99%)**, Import Cargo handled at Airports **(-16.80%)**, Passenger traffic handled at International terminal of the Airports **(-4.78%)** and Passenger traffic handled at Domestic terminal of the Airports **(-8.12%)**.

4. Under MPLADS, an amount of ₹ **127.50** crore have been released during the Month of **January 2020** and the total fund released during the financial year 2019-20 up to **31st January 2020** is ₹ **2855.00 crore**.

5. To review the activities of the Indian Statistical Institute (ISI), autonomous institute under the administrative control of the Ministry, the Committee, as per section 9 of the ISI Act, 1959 has been constituted under the Chairmanship of Dr. R.A. Mashelkar, National Research Professor, former Director General of Council of Scientific and Industrial Research and President, Indian National Science Academy. The constitution of the Committee has been notified on 28.01.2020.
