Major initiatives and achievements of the Ministry of Statistics & Programme Implementation during December 2021

The National Statistical Office (NSO) released Price Movement of Sub-Groups / Groups of Consumer Price Index (CPI) on Base 2012=100 for All India Rural, Urban, Combined for the month of **December 2021 (Provisional)** and for the month of **November 2021 (Final)**. The General Consumer Price Indices (CPI) for the month of **December 2021 (Provisional)** for Rural, Urban and Combined were 167.0, 165.1 and 166.1, showing an annual inflation rate of 5.36%, 5.83% and 5.59% respectively. The corresponding inflation rates (Final) for Rural, Urban and Combined for **November, 2021** were 4.29%, 5.54% and 4.91% respectively.

2. All-India Consumer Food Price Index (CFPI) for the month of **December 2021 (Provisional)** for Rural, Urban and Combined were 164.6, 171.7 and 167.1 respectively. All India year-on-year inflation rates for CFPI for the month of **December 2021** for Rural, Urban and Combined sector were 3.46%, 5.08% and 4.05% respectively. The corresponding inflation rates (Final) for Rural, Urban and Combined for **November 2021** were 1.09%, 3.33% and 1.87% respectively.

3. The All-India Index of Industrial Production (IIP) for the month of **November 2021** (Quick Estimates) with base year 2011-12 released on 12th January, 2022 and it stood at 128.5.

4. During the month of December 2021, the Ministry released the following important publication such as Strategy for “Environmental Economic Accounts in India: 2022- 2026”, Annual Report of the National Statistical Commission (NSC) along with Action Taken Report for the year 2020-21, Annual Report of the Indian Statistical Institute (ISI) for the year 2020-21 and Press Note on Payroll Reporting in India: An Employment Perspective - October 2021.

5. The major highlights of Central Sector Projects monitored under Online Computerized Monitoring System (OCMS) by this Ministry for the month of **December 2021** are as under:

6. As per the latest Review Report on the Performance of the Infrastructure Sectors up to the month of November 2021, Power Generation (**+8.38%**), Import Cargo handled at Airports (**+21.75%**), Passenger traffic handled at International terminal of the

Airports **(+55.19%)** and Passenger traffic handled at Domestic terminal of the Airports **(+9.43%) exceeded** its targets.

7. The Sectors that fell short of their targets are Coal Production (-12.10%), Fertilizers Production **(-16.67%)**, Crude Oil Production **(-4.38%)**, Refinery Production **(-1.04%)**, Natural Gas Production **(-7.90%)**, Upgradation of Highways by NHAI **(-19.45%)**, Upgradation of Highways by State PWD & Border Road Organization(BRO) **(-14.99%)**, Railways (-1.11%), and Export Cargo handled at Airports **(-2.14%)**.
