Major initiatives and achievements of the Ministry of Statistics & Programme Implementation for the month of January 2024.

The Ministry released the Press Note on the First Advance Estimates (FAE) of National Income for the financial year 2023-24, both at Constant (2011-12) and Current Prices. Real GDP or GDP at Constant (2011-12) Prices in the year 2023-24 is estimated to attain a level of ₹171.79 lakh crore, as against the Provisional Estimate of GDP for the year 2022-23 of ₹160.06 lakh crore, released on 31st May, 2023. The growth in real GDP during 2023-24 is estimated at 7.3 per cent as compared to 7.2 per cent in 2022-23.

2. The Ministry released Price Movement of Sub-Groups/Groups of Consumer Price Index (CPI) on **Base 2012=100** for All India Rural, Urban, Combined for the month of **January, 2024** (Provisional) and for the month of **December, 2023** (Final) on **12th February 2024**. The General Consumer Price Indices (CPI) for the month of **January, 2024** (Provisional) for Rural, Urban and Combined sector were 187.3, 183.5 and 185.5 showing an annual inflation rate of 5.34%, 4.92% and 5.10% respectively. The corresponding inflation rates (Final) for Rural, Urban and Combined sector for the month of **December, 2023** were 5.93%, 5.46% and 5.69% respectively.

3. All-India Consumer Food Price Index (CFPI) for the month of **January, 2024** (Provisional) for Rural, Urban and Combined sector were 187, 193.4 and 189.3 respectively. All India year-on-year inflation rates for CFPI for the month of **January, 2024** (Provisional) for Rural, Urban and Combined sector were 7.91%, 9.02% and 8.30% respectively. The corresponding inflation rates (Final) for Rural, Urban and Combined sector for the month of **December, 2023** were 9.03%, 10.42% and 9.53% respectively.

4. The All-India Index of Industrial Production (IIP) for the month of **December, 2023** (Quick Estimates) with the base year 2011-12 has been released on **12th February, 2024** and it stood at 151.5.

As per the latest Review Report on the Performance of the Infrastructure Sectors, the positive growth rate has been observed in April-December FY 23-24 over corresponding period of FY 22-23 across pertinent parameters viz. **[Power]** Power Generation (+6.98%), **[Coal]** Coal Production (+11.35%), **[Steel]** Production of Finished Steel (+14.11%), **[Cement]** Cement Production (+9.25%), **[Fertilizers]** Nitrogen, Phosphate and Urea Production (+10.90%), **[Petroleum and Natural Gas]** Crude Oil Processed (+3.20%), **[Petroleum and Natural Gas]** Natural Gas Production (+5.20%), **[Roads]** Upgradation of Highways by NHAI (+17.94%), Upgradation of Highways by State PWD & Border Road Organization(BRO) (+10.90%), **[Railways]** Passenger Traffic handled (+8.71%), **[Railways]** Gauge Doubling and New Lines (+86.49%), **[Railways]** Revenue earning Freight Traffic (+4.08%), **[Shipping]** Total Cargo handled at Major Ports (+4.93%), Coal handled at Major Ports (+2.13%), **[Civil Aviation]** Export Cargo handled at Airports (+9.84%), **[Civil Aviation]** Passenger traffic handled at International Terminals (+24.34%), **[Civil Aviation]** Passenger traffic handled at Domestic Terminals (+16.65%), **[Telecom]** Net new Wireline Telephone connections (+1.63%), **[Telecom]** Net new Wireless connections (+931.01%) and **[Telecom]** Towers including Base Transceiver Stations (+203.04%). However, the parameters that have shown negative growth rate are **[Petroleum and Natural Gas]** Crude Oil Production (-0.27%), and **[Civil Aviation]** Import Cargo handled at Airports (-1.36%).
