



Major initiatives and achievements of the Ministry of Statistics & Programme Implementation during September, 2020

1. The National Statistical Office (NSO) released Price Movement of Sub-Groups / Groups of Consumer Price Index (CPI) on **Base 2012=100** for All India rural, urban and combined for the month of August, 2020 (Provisional) on 14th September, 2020. As various pandemic related restrictions were gradually lifted and non-essential activities started resuming operations, availability of price data has also improved. The General Consumer price indices(CPI) for the month of August were 155.4, 154.0 and 154.7, showing an annual inflation rate of 6.66%, 6.80% and 6.69% respectively. The corresponding inflation rates (Final) for rural, urban and combined for **July, 2020** were 6.76%, 6.70% and 6.73% respectively.
2. All-India Consumer Food Price Index (CFPI) was released for the month of **August, 2020**. The figures for rural, urban and combined are 155.7, 161.6 and 157.8 respectively. All India year-on-year inflation rates for Consumer Food Price Index (CFPI) for the month of **August, 2020** for rural, urban and combined were 9.11%, 8.82% and 9.05% respectively. The corresponding inflation rates (Final) for rural, urban and combined for **July, 2020** were 9.47%, 8.99% and 9.27% respectively.
3. As per the Quick Estimates (QE) of Index of Industrial Production (IIP) with base year 2011-12 released on 11th September, 2020, the general index for the month of July, 2020 is 118.1.
4. A monthly bulletin on Economic Indicators titled "*National Fact sheet on Indian Economy*" containing 26 parameters was released for the first time on 15th September, 2020. It aims to provide a snapshot of rapidly moving indicators on the Indian Economy at one place for holistic view of economic developments.
5. The report of the first ever all-India survey on time use titled "Time Use in India-2019" (conducted during January – December 2019) has been released on 29 September, 2020.
6. An MoU was signed between MoSPI and Population Council Institute (PCI), New Delhi on 8th September, 2020 at Kolkata. The MoU provides a frame work for cooperation between the two parties in area of common interest such as reducing non-sampling bias in surveys through technological and behavioural change solutions, preparing quality assurance guidelines, tools and mechanisms to support other producers of government data in the country and introducing data science methodologies for monitoring the quality, supporting efficient analysis of surveys and administrative data, including application of artificial intelligence, machine learning and deep computing.

7. The highlights of the infrastructure sectors of the country monitored under Online Computerized Monitoring System (OCMS) for the month of July 2020 are as under:

7.1 The status of the ongoing Central Sector Projects costing Rs.150 crores and above are:

7.2 In the month of July, 2020, performance of upgradation of highways by state PWD & Border Road Organisation, export cargo, import cargo handled at airports and passenger traffic handled at International terminals of the airports have exceeded their monthly target by **60.31%**, **16.72%**, **13.47%** and **63.62% respectively**.

7.3 However, the sectors that fell short of their targets are Power Generation (**-7.36%**), Coal Production (**-22.52%**), Fertilizers Production (**-10.72%**), Crude Oil Production (**-3.53%**), refinery production (**-18.27%**) Natural Gas Production (**-11.47%**), Upgradation of Highways by NHAI (**-10.08%**), Railways (**-16.61%**) and Passenger Traffic handled at Domestic terminal of the Airports (**-39.89%**).
