Liort title and commencement.—(1) These rules may be called the Data Processing Division and Survey vit Grearch Division, National Sample Survey Organisation. (Accounts-cum-Administrative Officer and Office (Int) Recruitment Rules, 2008.

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law lightle to such person and the other party to the marriage and that there are other grounds for so doing, exempt any from the operation of this rule.

- 6. Power to relax.—Where the Central Government is of the opinion that it is necessary or expedient so to do, by order, for reasons to be recorded in writing, in consultation with the Union Public Service Commission relax any the provisions of these rules with respect to any class or category of persons.
- 7. Saving.—Nothing in these rules shall affect reservations, relaxation of age limit and other concessions ruled to be provided for the Scheduled Castes, the Scheduled Tribes, and other special categories of persons in wordance with the orders issued by the Central Government from time to time in this regard.
