G.S.R. 279.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution hereby makes the following rules regulating the method of recruitment to the posts of Assistant in the Miniand Programme Implementation, National Sample Survey Organisation, Data Processing Division and Sur

- 1. Short title and commencement.—(1) These rules may be called the Ministry of Statistical Implementation, National Sample Survey Organisation, Data Processing Division and Survey Design and Re Assistant, Group 'C' Post, Recruitment Rules, 2005.
  - (2) They shall come into force on the date of their publication in the Official Gazette
- 2. Number of posts, classification and scale of pay.—The number of posts, its classification pay attached thereto shall be as specified in Columns 2 to 4 of the Schedule annexed to these rules.
- 3. Method of recruitment, age limit and other qualifications etc.—The method of recruitment qualifications and other matters relating to the said post shall be as specified in columns 5 to 14 of
  - 4. Disqualification.—No person,—
    - (a) who has entered into or contracted a marriage with a person, having a spouse living
- (b) who, having a spouse living, has entered into or contracted a marriage with any per shall be eligible for appointment to the said posts:
- . Provided that the Central Government may, if satisfied that such marriage is permissible applicable to such person and the other party to the marriage and that there are other grounds for person from the operation of this rule.
- 5. Power to relax.—Where the Central Government is of the opinion that it is necessar may, by order, for reasons to be recorded in writing, relax any of the provisions of these rules will category of persons.
- 6. Saving.—Nothing in these rules shall affect reservations, relaxation of age limit required to be provided for the Scheduled Castes, the Scheduled Tribes, Ex-servicemen and out persons in accordance with the orders issued by the Central Government from time to time in the
