



**Agenda Note for Departmental Promotion Committee for promotion to the post of LDC in NSO(FOD), Hqrs. Office, Delhi & Faridabad in the Pay Level-2 (Rs. 19900-63200/-) of 7<sup>th</sup> CPC on regular basis in FOD against 10% quota on Departmental Qualifying Examination.**

There are 23 sanctioned post of LDC, group 'C', in the Pay Level-2 (Rs. 19900-63200/-) of 7<sup>th</sup> CPC at NSSO(FOD), including Faridabad Hqrs (19 post in Headquarter Office, Delhi and 04 post in Headquarter Office, Faridabad). All these posts are filled and no vacancy available at present. Name of 12 LDC is being considered for promotion to the post of UDC and after their promotion 12 vacancy may be incurred in vacancy year 2024, w.e.f 01.01.2024. Details of the post of LDC as on 01.01.2024 will be as under:-

2. As per existing Recruitment Rules of the post of LDC, 85% of vacancies are to be filled up by Direct Recruitment and 15% by Promotion (10% on the basis of Departmental Qualifying Examination and 5% on seniority-cum-fitness basis) of MTS who have three year of regular service in the Grade pay of Rs. 1800/-.

3. As per information available in the roster for DQE quota point no. 52 is earmarked for 10% Departmental Qualifying Examination respectively. Candidate has been joined against point No. 50 by transfer and offer of appointment has been issued against point No. 51 and the incumbent is supposed to join shortly. After his joining next point No. 52 is to be filled up by DQE quota against which the following incumbents possess eligibility criteria for promotion to the post of LDC against DQE quota: -

In terms of FOD O.M No. A-12026/27/99-E.III dated 12/17 November, 1999, a Model 100-point Roster w.e.f 25.01.1996 for giving effect to promotion of Group 'D' (now Group 'C') employees to the post of LDC in FOD Hqrs. Delhi/Faridabad against 5% quota on the basis of Seniority-cum-fitness and 10% quota from promotion of MTS who have qualified Departmental Examination conducted in FOD in the year 2019, has been prepared.
5. Result of Departmental Qualifying Examination 2019 of MTS for promotion to the post of LDC against 10% is placed in the folder.
