NOTIFICATION

G.S.R....... In exercise of the powers conferred by the proviso to Article 309 of the Constitution and in supersession of Data Processing Division, Industrial Statistics Wing, Kolkata Class III posts Recruitment Rules, 1986, the President hereby makes the following rules regulating the method of recruitment to the post of Assistant in the Data Processing Division, Industrial Statistics Wing, Kolkata in the Ministry of Statistics & Programme Implementation, namely:-

- 1. **Short Title and Commencement:-** (1) These Rules may be called the Ministry of Statistics and Programme Implementation, Data Processing Division, Industrial Statistics Wing, Kolkata, Assistant, Recruitment Rules, 2024.
- (2) They shall come into force on the date of their publication of the Official Gazette.
- 2. **Number of posts, classification, Pay Level or Grade Pay:-** The number of posts, its classification, Pay Level or Grade Pay attached thereto shall be as specified in columns (2) to (5) of the Schedule annexed to these Rules.
- 3. **Method of recruitment, age limit and qualifications, etc.**:- The method of recruitment, age limit, qualifications and other matters relating to the post shall be as specified in columns (6) to (13) of the said schedule.
- 4. **Disqualifications:** No person-
- (a) who has entered into or contracted a marriage with a person having a spouse living; or
- (b) who, having a spouse living, has entered into or contracted a marriage with any person,
- shall be eligible for appointment to the said posts:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and other party to the marriage and there are other grounds for doing so, exempt any person from the operation of this rule.

- 5. **Power to relax:-** Where the Central Government is of the opinion that it is necessary or expedient to do so, it may, by order, for reasons to be recorded in writing, and in consultation with Union Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.
- 6. **Saving :-** Nothing in these rules shall affect reservation, relaxation of age limit, and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, Ex- servicemen and Other Special Categories of persons in accordance with the Orders issued by the Central Government from time to time in this regard.
