**OFFICE MEMORANDUM**

**Subject: Non-Submission of Annual Immovable Property Return (IPR) by ISS officers for the year 2022 (as on 01.01.2023) through SPARROW portal -regarding.**


Reference is invited to Rule 18 of Central Civil Services (Conduct) Rules, 1964, which stipulates that every Government servant belonging to any service or holding any post included in Group 'A' and Group 'B' shall submit an annual return in such forms as may be prescribed by the Government, in this regard, giving full particulars regarding the immovable Property inherited by him or owned or acquired by him or held by him on lease or mortgaged either on his own name or in the name of any member of his family or in the name of any other person. Such return is required to be furnished in the prescribed form by **31<sup>st</sup> January of every year in respect of the previous year ending 31<sup>st</sup> December.**

2. After assessment, it has been observed that 20 ISS officers, have not submitted Immovable Property Return (IPR) online through SPARROW portal for the year 2022 status as on 01.01.2023.

3. It is reiterated that non-submission of IPR within the stipulated date, may lead to denial of Vigilance Clearance for several service related matters.

4. Accordingly, all ISS officers (as per list enclosed) are requested to file their IPR latest by **31.05.2023** failing which appropriate disciplinary action may be initiated against them without any further notice.
