## **Major initiatives and achievements of the Ministry of Statistics & Programme Implementation during November, 2021**

The National Statistical Office (NSO), Ministry of Statistics and Programme Implementation released Consumer Price Index (CPI) on Base 2012=100 for All India Rural, Urban, Combined for the month of **November, 2021 (Provisional)** and for the month of **October, 2021 (Final)** on 13<sup>th</sup> December, 2021. The General Consumer Price Indices (CPI) for the month of **November, 2021 (Provisional)** for Rural, Urban and Combined were 167.6, 165.6 and 166.7, showing an annual inflation rate of 4.29%, 5.54% and 4.91% respectively. The corresponding inflation rates (Final) for Rural, Urban and Combined for **October, 2021** were 4.07%, 5.04% and 4.48% respectively.

2. All-India Consumer Food Price Index (CFPI) for the month of **November, 2021 (Provisional)** for Rural, Urban and Combined were 166.7, 173.6 and 169.1 respectively. All India year-on-year inflation rates for CFPI for the month of **November, 2021** for Rural, Urban and Combined sector were 1.09%, 3.33% and 1.87% respectively. The corresponding inflation rates (Final) for Rural, Urban and Combined for **October, 2021** were 0.31%, 1.78% and 0.85% respectively.

3. All-India Index of Industrial Production (IIP) for the month of **October, 2021** (Quick Estimates) with base year 2011-12 released on 10<sup>th</sup> December, 2021 and it stood at 133.7.

4. The Ministry released the Press Note on Estimates of Gross Domestic Production (GDP) for the Second Quarter (July - September) of 2021-22 and Quarterly Bulletin of Periodic Labour Force Survey (PLFS) for January, 2021 to March, 2021, in the month of November, 2021.

5. The major highlights of Central Sector Projects monitored under Online Computerized Monitoring System (OCMS) by this Ministry for the month of **November, 2021** are as under:

As per the latest Review Report on the Performance of the Infrastructure Sectors up to the month of October 2021, Power Generation (**+9.51%**), Import Cargo handled at Airports (**+22.02%**), Passenger traffic handled at International terminal of the Airports (**+46.85%**) and Passenger Traffic handled at Domestic terminal of the Airports (**+6.11%**) **exceeded** its targets.

7. The Sectors that fell short of their targets are Coal Production (**-12.60%**), Fertilizers Production (**-17.55%**), Crude Oil Production (**-4.02%**), Refinery Production (**-1.73%**), Natural Gas

Production (-7.15%), Upgradation of Highways by NHAI (-20.37%), Upgradation of Highways by State PWD & Border Road Organization(BRO) (-7.54%), Railways (-0.71%), and Export Cargo handled at Airports (-1.94%).
