

Major initiatives and achievements of the Ministry of Statistics & Programme Implementation during January, 2023.

The National Statistical Office (NSO) released Price Movement of Sub-Groups/Groups of Consumer Price Index (CPI) on **Base 2012=100** for All India Rural, Urban, Combined for the month of **January, 2023** (Provisional) and for the month of **December, 2022** (Final) on 13th February, 2023. The General Consumer Price Indices (CPI) for the month of **January, 2023** (Provisional) for Rural, Urban and Combined sector were 177.8, 174.9 and 176.5 showing an annual inflation rate of 6.85%, 6.00% and 6.52% respectively. The corresponding inflation rates (Final) for Rural, Urban and Combined sector for the month of **December, 2022** were 6.05%, 5.39% and 5.72% respectively.

2. All-India Consumer Food Price Index (CFPI) for the month of **January, 2023** (Provisional) for Rural, Urban and Combined were 173.3, 177.3 and 174.7 respectively. All India year-on-year inflation rates for CFPI for the month of **January, 2023 (Provisional)** for Rural, Urban and Combined sector were 6.65%, 4.79% and 5.94% respectively. The corresponding inflation rates (Final) for Rural, Urban and Combined sector for the month of **December, 2022** were 5.05%, 2.80% and 4.19% respectively.

3. The All-India Index of Industrial Production (IIP) for the month of **December 2022** (Quick Estimates) with the base year 2011-12 has been released on **10th February 2023** and it stood at 144.7.

5. The major highlights of Central Sector Projects monitored under Online Computerized Monitoring System (OCMS) by this Ministry for the month of **January 2023** are as under:

As per the latest Review Report on the Performance of the Infrastructure Sectors up to the month of December 2022, Power Generation **(+10.86%)**, Refinery Production **(+1.33%)**, and Revenue earning goods Traffic at Railways **(+2.86%)** and Passenger traffic handled at International terminal of the Airports **(+9.00%)** **exceeded** its targets.

7. The Sectors that fell short of their targets are Coal Production **(-3.27%)**, Fertilizers Production **(-14.00%)**, Crude Oil Production **(-4.00%)**, Natural Gas Production **(-3.20%)**, Upgradation of Highways by NHAI **(-12.79%)**, Upgradation of Highways by State PWD & Border Road Organization(BRO) **(-31.79%)**, Export Cargo handled at Airports **(-18.65%)** Import Cargo handled at Airports **(-17.58%)**, and Passenger traffic handled at Domestic terminal of the Airports **(-5.28%)**.
