# NOTES ON METHODOLOGY AND REVISIONS IN THE ESTIMATES

The present series on National Accounts Statistics was introduced in February 1999 through a brochure entitled "New series on National Accounts Statistics (base year 1993-94)" after a comprehensive review of both the data base and the methodology employed in estimation of various aggregates. The estimates presented in this issue of National Accounts Statistics (NAS) are based on the methodology given in the above-mentioned brochure.

Besides the usual statements on macro economic aggregates, domestic product, consumption, saving and capital formation, public sector transactions and disaggregated statements, this issue includes five special statements. The Statement S-1 presents comparable estimates of important macro-economic aggregates and population from 1950-51 to 2003-2004, specially compiled on the new series with base year 1993-94, for ready reference of the users, incorporating (i) the changes as far as possible on account of additional coverage, conceptual and methodological improvements prior to 1993-94 and until 1980-81 and (ii) using splicing technique at disaggregated level, thereafter. statement S-2, as in the past gives depreciation as provided in the books of accounts for various institutions. The Statement S-3 gives value of output and domestic product from livestock sector utilising the input-output ratios as specially worked out for the Input-Output Transactions Tables. The special statement S-4 gives advance estimates of national income for the year 2004-2005 at current and constant (1993-94) prices. The CSO has been releasing advance estimates of national income before the close of the year. methodology for preparing the advance estimates has been published in the NAS, 1994. The current price estimates have been compiled by building up a regression model between the Wholesale Prices Index (WPI) and the Implicit Prices Deflators (IPD) of the gross domestic product, utilising the past data. The IPD are the ratios of the current price estimates to constant price estimates. The relationship of WPI and IPD from the past data read along with the current figures of WPI gives the relevant IPD for the period of reference. The quarterly estimates of GDP for the years 2000-01 to 2004-05 are given in the special statement S-5. The methodology of compiling these quarterly GDP estimates developed by the CSO is already given in NAS-1999.

The sources of revisions in the estimates made due to availability of fresh/revised data are given below:

## REVISION OF ESTIMATES DUE TO FRESH/REVISED DATA

The quick estimates and the estimates for the previous years of macro economic aggregates and their disaggregated components published in NAS 2004 have undergone revision due to fresh/revised data becoming available. Sources of data utilised for the revision of the estimates are given below:

#### 18. Consumption of Fixed Capital

Estimates of consumption of fixed capital are prepared from the value of various types of assets included in fixed capital stock and the expected life thereof and these estimates differ from the provision of depreciation as per books of accounts (c.f. National Accounts Statistics, Sources and Methods, 1989). Depreciation as per books of accounts is given in special statement S-2. Alternative estimates of net Saving / Capital formation can be derived using provision for depreciation. These estimates have undergone revision since 2001-02 due to changes in the estimates of gross fixed capital formation.

#### C: Public Sector Transactions

- 19.1 Statements on Public Sector Transactions have undergone revision from 2001-02 onwards due to availability of additional/revised/fresh data in respect of Departmental Enterprises and Administrative Departments from budget documents, annual accounts of RBI, Employees Provident Fund Organisation (EPFO), research and scientific institutions covered in 'Public Services in Quasi-Govt. Bodies' and the annual accounts of Non-Departmental Enterprises those have been analysed, represent about 95 percent of paid-up capital of all such enterprises for the year 2002-03.
- 19.2 The entire expenditure incurred under "Member of Parliament Local Area Development Scheme (MPLADS)" has been classified as capital formation as the emphasis of the scheme is for creation of durable assets.
