

9. INDUSTRY

This section deals with the following items:

- (a) Annual Survey of industries-Factory sector,
- (b) Production of cotton yarn,
- (c) Production of cotton cloth,
- (d) Production of man-made fibre fabrics,
- (e) Production of certain selected industries and
- (f) Index numbers of industrial production.

Table 9.1 and 9.2

These two tables present data regarding Annual Survey of Industries(ASI), the scope and coverage of which are described below:

The ASI replaced both the Census of Manufacturing Industries (CMI) and the Sample Survey of Manufacturing Industries (SSMI) with effect from the survey year, 1959. The survey is conducted under the statutory provisions of "Collection of Statistics Act, 1953" and the rules framed there-under in 1959, except in Jammu and Kashmir where it is conducted under the State Collection of Statistics Act, 1961 and the Rules framed there-under in 1964. These tables give information on important characteristics of manufacturing industries for some latest years (factory-sector), State - wise and industry group-wise.

The ASI extends to the entire country except the States of Arunachal Pradesh, Mizoram, Nagaland, Sikkim and Union Territory of Lakshadweep. It covers all factories registered under section 2 m(i) and 2 m(ii) of the Factories Act of 1948, which respectively refer to the factories employing 10 or more workers and using power and those employing 20 or more workers but not using power on any day of the preceding 12 months. The survey also covers bidi and cigar manufacturing establishments registered under Bidi and Cigar Workers (Condition of Employment) Act, 1966 and employing 10 or more workers using power and 20 or more workers not using power. All the electricity undertakings engaged in the generation, transmission and distribution of electricity registered with the Central Electricity Authority are covered under ASI irrespective of their employment size. Certain services and activities like cold storage, water supply, repair of motor vehicles and other consumer durables like watches etc, are covered under the Survey.

Defence establishments, oil storage and distribution depots., restaurants, hotels, cafes and computer services and also the technical training institutes are excluded from the purview of the Survey. Since 1966 onwards ASI relates to the accounting year of the factories on any day between 1st April to 31st March of the next year. The Annual Survey of Industries upto 1965 related to the calendar year with the exception of sugar, cotton ginning and pressing factories and electrical undertakings for which the reference periods were respectively the year ending 30th June, 31st August and 31st March respectively. Reference year is accounting year of the factory ending on 31st March.

Definitions and concepts of some of the terms used in these tables are mentioned below:

Fixed Capital: represents the depreciated value of fixed assets owned by the factory as on the closing date of the accounting year. Fixed assets are those which have a normal productive life of more than one year. Fixed capital covers all types of assets, new or used or own constructed, deployed for production,

transportation, living or recreational facilities, hospitals, schools, etc. for factory personnel. It includes the fixed assets of the head office allocable to the factory and also the full value of assets taken on hire-purchase basis. (whether fully paid or not) excluding interest element. It excludes intangible assets and assets solely used for post manufacturing activities such as sale, storage, distribution etc.

Physical Working Capital: is defined to include all physical inventories owned, held or controlled by factories as on closing date of the accounting year such as the materials, fuels & lubricants, stores etc. that enter into products manufactured by the factory itself or supplied by the factory to others for processing. Physical working capital also includes the stock of the materials, fuels and stores etc. purchased expressly for resale, semi-finished goods and work in progress on account of others and goods made by factories which are ready for sale at the end of accounting year. However, it does not include the stock of the materials, fuels, stores etc. supplied by others, to the factory for processing, finished goods, goods processed by others from raw materials supplied by the factory and held by them or included and finished goods processed by the factory from raw material supplied by others are excluded.

Working Capital: is the sum total of the physical working capital as already defined above and the cash deposits in hand and at bank and the net balance of amounts receivable over amounts payable at the end of the accounting year. Working capital, however, excludes unused overdraft facility, fixed deposits irrespective of duration, advances for acquisition of fixed assets, loans and advances by proprietors and partners irrespective of their purpose and duration, long term loans including interest thereon and investments.

Productive Capital : is the total of fixed capital and working capital as defined above.

Invested Capital: is the total of fixed capital and physical working capital as defined above.

Depreciation: is consumption of fixed capital due to wear and tear and obsolescences during the accounting year and is taken as provided by the factory owner or is estimated on the basis of cost of installation and working life of the fixed assets.

Workers : are defined to include all persons employed directly or through any agency whether for wages or not and engaged in any manufacturing process or in cleaning any part of the machinery or premise used for manufacturing process or in any other kind of work incidental to or connected with the manufacturing process or the subject of the manufacturing process. Labour engaged in the repair and maintenance or production of fixed assets for factories own use or labour employed for generating electricity or producing coal, gas are included. However, persons holding positions of supervision or management, or employed in administrative office, store keeping section and welfare section, sales department as also those engaged in the purchase of raw materials etc. and in production of the fixed assets for the factory and watch and ward staff, are excluded."

Total Persons Engaged: relates to all persons engaged by the factory whether for wages or not, in work connected directly or indirectly with the manufacturing process and include all administrative, technical, clerical staff as also labour engaged in production of capital assets for factory's own use. This is inclusive of persons holding supervisory or managerial positions or engaged in administrative office,

Store keeping section and welfare section, sales department as also those engaged in the purchase of raw materials etc. and the production of fixed assets for the factory and watch and ward staff. It also includes all working proprietors and their family members who are actively engaged in the work of the factory even without any pay and the unpaid members of the co-operative societies who worked in or for the factory in any direct and productive capacity.

The number of workers or employees is an average number, obtained by dividing man days worked defined later by the number of days the factory had worked during the reference year. In case of factories where only repair, maintenance or construction activities are carried, the average is calculated by dividing the man days worked by the number of days, repair and maintenance/constructions work was carried on.

Mandays: represents the total number of mandays worked and not man days paid for by the factory during the accounting year. It is obtained by summing-up the number of persons of specified categories attending in each shift over all the shifts worked on all days (working and non-working).

Wages : are defined to include all remunerations capable of being expressed in monetary terms and also payable more or less regularly in each pay period to workers, defined above as compensation for work done during the accounting year. It includes a) direct wages and salary (ie. basic wages/salaries, payment of overtime, dearness, compensatory, house rents and other allowances), (b) remuneration for period not worked (i.e. basic wages, salaries and allowances payable for leave period, paid holiday, lay-off payments and compensation for unemployment, if not paid from sources other than employers), (c) bonuses and ex-gratia payments paid both at regular and at less frequent intervals (ie. incentives bonuses, good attendance bonuses, productive bonuses, profit sharing bonuses, festival or year end bonuses etc.). It excludes lay-off payments which are made from trust or other social funds set up expressly for this purpose i.e. payments not made by the employer. It also excludes imputed value of the benefits in kind, employer's contribution to the old-age benefits and other social security charges, direct expenditure on maternity benefits and crèches and other group benefits. Traveling and other expenditure incurred for the business purposes and re-imburshed by the employer are excluded. The wages are expressed in terms of gross value i.e. before deduction for fines, damages, taxes, provident funds, employee's state insurance contribution etc.

Total Emoluments: are defined in the same way as wages defined above but paid to all employees plus plus imputed value of benefits in kind i.e the net cost to the employer on those goods and services provided to employees free of charge or at markedly reduced cost which are clearly and primarily of benefits to the employees as consumers.

Contribution to Provident and Other Funds: includes old age benefits like provident fund, pension, gratuity etc. and employer's contribution towards other social security charges such as employee's state insurance, compensation for work injuries, occupational diseases, provident fund linked insurance, retrenchment and lay-off benefits.

Workmen and staff welfare expenses include group benefits like direct expenditure on maternity, crèches, canteen facilities; educational, cultural and recreational facilities and grants to trade unions, co-operative stores etc. meant for employees.

Old Age Benefits: relate to employer's contribution to old age benefits like provident fund, pension, gratuity etc.

Social Security Charges: include employer's contribution towards other social security charges such as employee's state insurance, compensation for work injuries, occupational diseases, maternity benefits, retrenchment and lay-off benefits etc.

Other benefits: consist of direct expenditure on maternity, crèches, canteen facilities, educational, cultural and recreational facilities and grant to trade unions, co-operative stores etc., meant for employees.

Fuels Consumed: represent total purchase value of all items of fuels, lubricants, electricity, water etc. consumed by the factory during the accounting year including gasoline and other fuels for vehicles except those which directly enter into products as materials consumed. It excludes that part of fuels which is produced and consumed by the factory in manufacture i.e., all intermediate products and also fuels consumed by employees as part of amenities. It includes quantities acquired and consumed from allied concerns, their book value being taken as their purchase value and also the quantities consumed in production of machinery or other capital items for factory's own use.

Materials Consumed: represents the total delivered value of all items of raw materials, components, chemicals, packing materials and stores which actually entered into the production process of the factory during the accounting year. It also includes the cost of all materials used in the production of fixed assets including construction work for factory's own use. It, however, excludes all intermediate products consumed during the accounting year (Intermediate products in the above context mean all those products which are produced by the factory but are subject to further manufacturing process).

Total Input: comprises total value of fuels, materials consumed as defined above as well as expenditures such as (a) cost of contract and commission work done by others on materials supplied by the factory (b) cost of materials consumed for repair and maintenance of factory's fixed assets including cost of repairs and maintenance work done by others to the factory's fixed assets; (c) inward freight and transport charges, rates and taxes excluding income taxes; postage; telephones and telex expenses; insurance charges; banking charges; and cost of printing and stationary etc.

Products: Include the ex-factory value (i.e. exclusive of taxes, duties etc. on sale and inclusive of subsidies etc., if any) of all products and by-products excluding intermediate products that have been completed during the accounting year for sale whether actually sold during the accounting year or not. Also include fixed assets produced by the factory for its use. It also includes the net value of change in the stock of semi-finished goods representing the excess of change in the stock of semi-finished goods at the end of accounting year that at the beginning of the year.

Semi-Finished Goods: refer to the imputed value of all materials which have been partially processed by the factory but which are not usually sold without further processing. It includes the work in progress on account of others, but excludes the value of semi-finished fixed assets produced for factory's own use.

INDUSTRY-Contd.

Gross Output: is defined to include the ex-factory value of products and by-products manufactured (as defined above) during the accounting year. It also includes the receipt for non-industrial services rendered to others, the receipt for work done for others on materials supplied by them, value of electricity sold and net balance of goods sold in the same condition as purchased. The term Gross output, value of output and total output have been used in the text interchangeably to mean the same thing.

Net Value Added: is the increment to the value of goods and services that is contributed by the factory and is obtained by deducting the value of total inputs and depreciations from value of output.

Rent Paid: represents the amount of royalty paid in the nature of rent for the use of the fixed assets in the factory.

Interest Paid: includes all interest paid on factory account on loans, whether short term or long term, irrespective of duration and the nature of agencies from which the loan was taken. Interest paid to partners and proprietors on capital or loan are excluded.

Net Fixed Capital Formation: represents the excess of net fixed capital at the end of accounting year over that at the beginning of the year.

Gross Fixed Capital Formation: is obtained by adding depreciation to net fixed capital formation as mentioned above.

Presents data on Mill Production of Cotton Yarn by Weight state wise.

Table 9.4

Presents cotton cloth production data by length/area distinguishing it according to the category of cloth namely coarse, medium, fine, etc. The data regarding total cloth produced by the decentralized sector of the cotton textile industry have also been shown in this table. Collection of category wise details of cotton cloths is discontinued from 1996-97.

Table 9.5

Presents data (2004-05) regarding man-made fiber fabrics refers to production by mill (including weaving unit), handloom, power looms and hosiery sectors. Man-made fiber fabrics comprise art silk, synthetic fabrics and staple fiber fabrics.

Table 9.6

This table presents data on production of selected items in India. The data are based on the monthly production data obtained from different Administrative Departments/ Ministries for preparation of All India Index of Industrial Production, which may not necessarily be the total production of the respective items in the country.

INDUSTRY-Concl.

Table 9.7

This table presents the index numbers of industrial production with base 1993-94=100. The first index called the Interim Index of Industrial Production with 1946 as the base, covered 35 items. It was revised to base year 1951, increasing the number of items to 88 and was published in October, 1955. This was again revised and published in July 1962 after shifting the base to 1956 and covering 201 items. The index was subsequently revised to base 1960=100. The monthly index of this series was based on 312 items and the annual index was based on 436 items. These index numbers were published in July-August, 1967 (Supplement) of Monthly Statistics of Production of Selected Industries. This index has been further revised to base 1970=100. These index numbers have been published in March 1975, issue of Monthly Statistics of Production of Selected Industries. Again the Index has been revised with 1993-94 as base year was released for the first time May, 1998 and published in MAS May-June 1998 issue.

The index is a simple weighted arithmetic mean of production relatives, the weights being proportional to gross value of output as available from ASI-1993-94 factory sector. At the industry indicator levels, the weights were allocated in proportion to their gross value of output. The index is calculated by the formula:

$$I = \frac{\sum R_i W_i}{\sum W_i}$$

Where I is the index, R_i is the production relative for the item 'i' for the month in question and with weight allotted to it. The index has been revised from time to time to reflect adequately the industrial growth by shifting the comparison base to a recent period by covering larger number of items and industries and by improving, as far as practicable, the technique of construction.

The table present Annual Averages of IIP at one and two digit codes of industries.

(FACTORY SECTOR)



MILL PRODUCTION OF COTTON YARN


