Ever since 1957-58, an economic classification of the Central budget is being prepared by Economic Division of the Ministry of Finance. The system of Accounts given in this table analyses various aspects of the Central Government's transactions vis-a-vis rest of the economy. Some of the significant magnitudes emerging from the analysis are:

- (a) the Central Government's total expenditure;
- (b) the Central Government's final outlays;
- (c) Capital formation out of the budgetary resources of the Central Government;
- (d) Net Capital formation and savings of the Central Government;
- (e) the various measures of deficit in the Central Government's budgetary transactions; and
- (f) Income generation by the Central Government.
