- 2. Coordination & Publication Division (CPD), NSSO will handle all the work related to designating CPIOs and FAAs for all the field offices under NSSO including IS Wing, Kolkata and CPD itself.
- 3. In the event of designated CPIOs/FAAs availing leave or transferred or retired or the post lying vacant for any other reason, the Link Officer or the newly joined officer in place of the earlier one or the chain of officer down the line would

act as CPIO/FAA to fulfill the duties bestowed under the RTI Act until further order.

- 4. RTI Cell has already created and conveyed Login IDs and passwords to access RTI MIS portal for every CPIO and First Appellate Authority. RTI applications or First Appeals which are received online through RTI-MIS portal of the Ministry would be forwarded to the concerned CPIOs or FAAs online through RTI-MIS portal only. All the CPIOs and FAAs are again requested to ensure the 'daily monitoring' of their respective account on RTI-MIS portal.
- 5. It is also clarified that all the pending RTI First Appeals with the Appellate Authorities or First Appeals received in future in respect of past RTI applications which are dealt by the CPIO in existing set-up will be disposed off by the erstwhile FAAs.
