- 2. **FOD Hq** will handle all works related to designating CPIOs and FAAs for their field offices and AS Hq. along with other subordinate offices under its jurisdiction.
- 3. In the event of designated CPIOs/FAAs availing leave or transferred or retired or the post lying vacant for any other reason, the Link Officer or the newly joined officer in place of the earlier one or the chain of officer down the line would act as CPIO/FAA to fulfill the duties bestowed under the RTI Act.
- 4. RTI Cell has created Login ID and password to access RTI-MIS portal for every CPIO and First Appellate Authority. RTI applications or First Appeals which are received online through RTI-MIS portal of the Ministry would be forwarded to the concerned CPIOs or FAAs online through RTI-MIS portal only. All the CPIOs and FAAs may be requested to ensure the 'daily monitoring' of their respective RTI-MIS portal.
- 5. All the Sections/ Divisions may be also requested to intimate promptly to the RTI Cell of the Ministry regarding any change/ updation in the RTI-MIS account of respective CPIOs/FAAs in the Ministry.
