02. The officers are entitled for fixation of pay as per the provisions of CCS (Revised Pay) Rules, 2008 and the MACP guidelines.

03. The 3% pay fixation benefits extended on account of Ad-hoc promotions to JTS of ISS vide this Ministry OM No. 12039 /01 /2013 – SSS dated 20th April 2011 may be recovered with all consequential benefits in the light of subsequent OM No. 12039 / 01 / 2013 – SSS dated 6th January 2014, if any, before extending the financial benefits under 3rd MACP.

04. The Participating Ministries / Departments / Organizations of SSS are requested to fix the pay under higher Grade Pay after due verification of eligibility condition of MACP from the service records of the officers.

05. Orders relating to 2nd and 3rd MACP, if any, in GP of Rs. 4800 and Rs.5400 (PB-2) in respect of these incumbents may be treated as cancelled.

06. The Participating Ministries / Departments / Organizations of SSS are requested to ensure that officer placed in the higher Grade Pay under MACP, is not under suspension **or** no charge sheet has been issued **or** no disciplinary proceeding **or** prosecution case for criminal charge is pending against him as on date of MACP.

07. The officer, if any, who is under currency of penalty, will be placed in the next higher Grade Pay only on expiry of that period.

08. The Participating Ministries / Departments / Organizations of SSS are requested to provide copy of this order to all concerned incumbents and place a copy of the same in the service book of the concerned officials.

Office Memorandum

Sub: Pay fixation on promotion after MACP of SSS incumbents - regarding.

The undersigned is directed to say that a point was raised whether an employee who has been granted 3rd MACP on completion of 30 years of service in the Grade pay of Rs. 5400 under Pay Band -2 and subsequently promoted to the post of JTS of ISS under Pay Band -3 in the Grade Pay of Rs. 5400 is further eligible for 3 % pay fixation benefits. This issue was referred to DOP&T and it has been clarified by DOP&T that in view of sub-para (i) of para 13 of 6th CPC Notification dated 29th August 2008 the benefit of one increment equal to 3% shall be admissible at the time of pay fixation on promotion in higher pay band viz **PB-2 to PB -3 (Grade Pay of Rs. 5400/-)**. However, no difference of Grade Pay would be admissible at this stage as there is no difference in the grade pay of lower and higher pay bands. In view of this all participating Ministries / Departments / Organisations of SSS are requested to fix the pay of concerned officials accordingly.

**Subject: Pay fixation on promotion of SSS incumbents after getting MACP–
Regarding. ✓**


The undersigned is directed to refer to this Ministry's OM of even number dated 20th April 2011 vide which it was clarified that 3% pay fixation benefit is allowed to those incumbents of SSS, who have been granted 1st, 2nd or 3rd MACP in the GP of Rs. 4800 and Rs. 5400 (PB-2) and subsequently they were promoted as Assistant Director (JTS of ISS) in the GP of Rs. 5400 (PB-3).

2. The above issue has been re-examined in consultation with DOP&T and Ministry of Finance and it has now been decided that:

- (i) The OM of even number dated 20th April 2011 **(Copy enclosed)** stands withdrawn with retrospective effect from the date of issue and the benefit of 3% pay fixation shall not be admissible, on account of promotion as JTS of ISS in GP of Rs. 5400 (PB-3), even on change of Pay Band, in the light of condition 4 of MACP Scheme. However, only the difference of GP, if any, shall be payable.
- (ii) The excess payment, already made shall be recovered from the concerned incumbents in three equal monthly installments. In case an official is going to superannuate earlier, the duration of recovery may be reduced accordingly. However, it may be ensured that the excess payment, in any case, has to be recovered before his superannuation.

3. All participating Ministries / Departments / Organizations are requested to take immediate action to re-fix the pay of the concerned incumbents under intimation to this Ministry.
