**ORDER**

**Subject:- Postings/Transfers of SSS Officers—decision on requests for retention/extension/cancellation of Orders, dated 18-8-2023—regarding.**

Kind reference is drawn to this Ministry's three Orders of even number, dated 18-8-2023 regarding postings/transfers of SSS officers.

2. The Ministry has so far received various requests/representations directly or through the respective offices in respect of the officers (as per annexed list), on the above orders, for retention at their present place of postings/change in place of postings/cancellation of transfers/extension in joining time etc. These requests/representations have been examined/considered and the Competent Authority has decided not to accede the same.

3. The concerned officers (SSOs) transferred in the same capacity are accordingly directed to comply with the above orders issued by the Ministry and report to the respective place of posting at the earliest and maximum by 06-10-2023. The concerned offices are directed to relive them at the earliest on joining of new incumbents or maximum by 06-10-2023 in compliance to the above orders dated 18-08-2023.

4. As directed in the order dated 18-08-2023, the newly promoted SSOs shall be stand relived as on 01.09.2023 (A/N), if not relieved till then. If the newly promoted officers are not relived by 01-09-2023 (A/N), it will be presumed that the officer has foregone his/her promotion and no request for joining as SSO shall be entertained thereafter by the Ministry.

5. Also, FOD, Hqrs. and other Ministries/Departments/Organizations are requested not to accede to the requests of officers for extension in joining time at their new place posting.
