- The postings of officers at Sr.No.1 to 9 are on administrative requirements; they would be entitled for admissible joining time/TA/DA, etc. Transfers of officers from Sr.No.10 to 18 are at their own request and therefore may be treated at Own cost; they would not be entitled for any joining time/TA/DA, etc. The officers at Sr.No.1 to 6 will stand relieved of their duties w.e.f. 19.05.2017 (A.N.) to join at their new place(s) of duty.
- Shri Ajeet Kumar, SSO, NSSTA, Gr. NOIDA and Shri H.P. Pathak, SSO, BPRD, New Delhi, on their repatriation reported in the SSS Cadre on 01.05.2017 (F.N.) and 02.05.2017 (A.N.) respectively. The period in respect of Shri Ajeet Kumar and Shri H.P. Pathak w.e.f. 01.05.2017 to 19.05.2017 and 03.05.2017 to 19.05.2017 respectively may be treated as compulsory wait in the Cadre for regulating their salary and admissible pay and allowances, etc. which shall be paid by the respective offices where they have been posted.
- The transfer order in respect of Smt. S. Premavathy (EC-2954), SSO, NSSO (FOD), Coimbatore to NSSO (FOD), Chennai dated 13.02.2017 is hereby stand cancelled.

- 5. The officers at Sr.No.8, 9 and 19 to 48 may be relieved from their present place(s) of posting to join the place(s) of posting as mentioned above, without asking them to join the place(s) of posting as per the Order of even number dated 27.04.2017, if they have not joined there yet, treating these as transfers on promotion. Since the posting(s) of these officers stands revised as above at their own request, it may be treated at Own cost; they would not be entitled for any joining time TA/DA, etc., if the officer has already assumed charge at the earlier place of posting, as per the posting on Promotion Order dated 27.04.2017. However, if the officer has not joined the earlier place of posting, the posting stands diverted to the new place of posting as per the instant Order dated 17.05.2017; the officer would be entitled for admissible joining time/TA/DA, etc. **The promotion will be effective from the date of assumption of charge of the new post.**
- 6. The concerned Ministries/Departments/Organizations, where the officers are presently working, are requested to relieve the officers to join the Ministry/Department where they have been posted as above, without waiting for a substitute, to enable them to avail their regular promotion to SSO in SSS. The officers who have been transferred/posted against the future vacancies or against the officers who have been transferred or posted against the future vacancies may be relieved to assume their charge against the distinct vacancies as indicated above.
- 7. The concerned Ministries/Departments/Organizations may please ensure that the officers concerned are clear from vigilance angle before they assume charge of the new posts in terms of DoP&T OM No.22034/4/2012-Estt.(D) dated 02.11.2012 and other relevant instructions on the subject.
- 8. The concerned Ministries/Departments/Organizations may please ensure that authenticated copy of Joining Report, duly signed by Head of Office, is sent to this Ministry by Speed Post and also through email at: dir-sss-mospi@nic.in.
