ORDER

In continuation to this Division's Office Order of even number dated 20.8.2010 and in reference to MOS&PI letter no. C-18013/11/2002-Ad III dated 29.6.2011, the following direction of the Hon'ble High Court of Andhra Pradesh, Hyderabad which was sustained by Hon'ble Supreme Court vide order dated 11.5.2010 while dismissing Civil Appeal No.8273 of 2004, may be implemented forthwith:

"the petitioners holding the post of Assistant Superintendent after 1.1.1986 by virtue of promotion are entitled to have the benefit of Rs. 75/- special pay in the revised pay scale of Rs.1600-2660. But, however, in the further revised pay scales of V Pay commission their pay has to be appropriately fixed taking into consideration the special pay of Rs.75/- and its merger in V Pay commission scales".

It is informed that the aforesaid judgment will be implemented in the case of applicants including applicants for intervention as per Hon'ble Supreme Court order dated 13.4.2010 in Civil Appeal no.8273/2004, a list of which is enclosed.

Accordingly, all the Heads of Office are requested to grant the Special Pay of Rs. 75/- to the applicants including applicants for intervention, promoted to the post of Assistant Superintendent after 1.1.1986, from the date of promotion in the pay scale of Rs.1600-2660. However, their pay in the revised pay scales of V Pay commission w.e.f. 01.01.1996 may be fixed under Rule 7 (1) (B) of CCS(RP) Rules 1997 taking into consideration the special pay of Rs.75/- and its merger in V Pay commission scales.

The direction of Hon'ble High Court of Andhra Pradesh, Hyderabad may be complied with scrupulously and compliance be furnish to this Division immediately
