- 2. The promotion will be effective from the date of assumption of charge of the new post and till further orders. It is also stated that adhoc promotions are being made purely as a temporary measure and as a stopgap arrangement and can be withdrawn/cancelled at any time without assigning any reasons. The promotion will not bestow on the above mentioned officers any claim, whatsoever for regular appointment and adhoc service will not be counted for the purpose of seniority in that grade and for eligibility for promotion, etc.
- 3. It has been decided by the CCA of SSS that posting of above mentioned incumbents within NSSO (FOD) on promotion may be decided by NSSO (FOD) Headquarters itself. A copy of guidelines for posting on promotion as approved by CCA of SSS is hereby enclosed for facilitating in deciding the posting of abovementioned incumbents. Applications received in the cadre from some of abovementioned incumbents who have indicated their choice stations on promotion due to various reasons is also enclosed for consideration.
- 4. It has further been decided to delegate the power of posting/transfer within NSSO (FOD) in respect of all other S.I. Gr. I working in FOD to NSSO (FOD) Headquarters until further orders. The transfer requests within FOD received from incumbents in SSS Division will be sent to FOD Headquarters in due course. Powers of transfer/posting of SSS incumbents from FOD to non-FOD or vice versa or within non-FOD will continue to be exercised, as hitherto, by the CCA of SSS.

Guidelines to be adopted for Ad hoc Promotion from S.L. Gilli to S.L. Gill

- (i) As per precedence, seniors will be considered for posting at the same station and junior will move out on ad hoc promotion, due to lack of vacancy at the same station.
- (ii) All female candidates, who are promoted, may be posted at their present place of posting on in-situ basis, due to lack of vacancy at the same station.
- (iii) Persons promoted having less than one year of service will be posted on in-situ basis, at the same station.
- (iv) Keeping in view large number of vacancies of S.I. Grade-II in NSSO (FOD) offices located in J&K, NE States and Andaman & Nicobar Islands, the incumbents will be promoted on in situ basis and can continue at the same station till they are promoted on regular basis.

Note: While issuing the Order of promotion and posting, it may be mentioned that incumbents retained in same office on in-situ basis will not have any right to continue in same office/station at the time of their regular promotion.
