5. The officer, if any, who is under currency of penalty, will be placed in the next higher Grade Pay as per MACP only on expiry of that period.

6. The Participating Ministries / Department / Organization of SSS is requested to provide copy of this order to all concerned incumbents and place a copy of the same in service book of officials.
