### Tender Notice for Comprehensive AMC of Photocopier machine

The tenders will be opened on 07.01.2020 at 11:00 hrs. in the presence of representative of the firms who wish to attend.

2. The details of the photocopier for which tenders are invited for Comprehensive Annual Maintenance Contract and the format in which tender is to be submitted is given below:

  (i) A refundable Bid Security (EMD) of Rs. 1000/- in form of Account Payee Demand Draft or bank guarantee from any of the Commercial banks in favour of 'Head of Office, NSSO(DPC), Ahmedabad' is to be enclosed with the tender. The bid security should remain valid for a period of ninety days from the closing date of the submission of tender.
  - (ii) The tender submitted without EMD will be rejected summarily.

4. While submitting the quotation the following conditions should be followed .

(i) The firm should have office in Ahmedabad and should provide documentary evidence of PAN & GST number etc., if applicable.

(ii) Tenders may be addressed to "Head of Office, DPC, NSSO, 7th Floor, Lilamani Corporate heights, Opp. BRTS bus Stop, Vadaj, Ahmedabad-380013" Superscribing "Tender for CAMC of photocopier" on the top of the sealed envelop, indicating the firm name and full address including telephone number at the bottom of the left hand side of the envelope.

(iii) The Tenders may be sent through registered post/Speed post/by hand. However, this office will not be responsible for any postal delay.

- (iv) Tender should be submitted in the format given at para 2 above. Besides, tenders should be on the letter head of the firm or duly stamped by the signing authority.
- (v) Tenders will be evaluated on the basis of Grand total Amount given at item Sr.No. 3 of the above mentioned form.
- (vi) NSSO-DPC, Ahmedabad, reserves the right to accept/reject any or all tenders without assigning any reason.

#### 5. The Terms and conditions of the Contract will be as given below:

- (i) The quoted rate should be valid for one year from the date of signing the agreement.
- (ii) The Comprehensive AMC also includes replacement of the parts except consumable parts, if required, without any extra cost and the same should be of standard quality.
- (iii) The equipment will not be moved out of our office premises without prior permission and valid gate pass. All transportation costs involved for this purpose will be borne by the firm.
- (iv) Normal service hours will be from 10.00 AM to 5.00 PM on all working days (Monday to Friday) however, in exceptional circumstances, services may need to be provided outside of these hours or on Saturday/Sunday/Holidays at the discretion of and convenience of the office.
- (v) Apart from break-down/fault call, there will be a preventive maintenance check effective working of equipment at regular internal in each quarter.
- (vi) Payment will be made on quarterly basis at the end of the each quarter on satisfactory completion of the contractual obligations.
- (vii) Penalty Charges @ Rs. 200/- per day will be levied and deducted from payment in case of failure to attend the call/complaint within one working day of recording the same with the firm. In case, the equipment is required to be taken to the workshop for repairing, standby equipment shall be provided, free of any cost to this office.
- (viii) NSSO-DPC, Ahmedabad, reserve the right to terminate the arrangement by giving one month's prior notice in writing and accordingly recalculate AMC charges on pro rata basis for the period for which services was provided.
