Subject: On site Annual Comprehensive Maintenance Contract for Computer Hardware (Sun Servers V890, PC, Switches), LAN (including Networking Equipments) and System Software on 24 X 7 basis (365 Days including holidays).

Sealed quotations are invited from Reputed Firms, registered or having branch office in the NCR of Delhi (on official letter heads) with duly filled in Annexure – II & III to award of Annual Comprehensive Maintenance Contract (AMC) for Computer Hardware(SUN Servers V890, PCs, Switches, LAN (including Networking Equipments) and System Software on 24*7 basis (365 Days including holidays). The list of hardware/software items is indicated in Annexure-I.

- A) The firms who fulfill the following eligibility conditions need only apply:
- 1) The firm should be at least a 'Private Limited' (if not public Limited) and should be in existence for over 5 Years in the trade of maintenance of Computer Hardware, LAN (including Networking Equipments) and System Software etc. and should be having a turnover of at least Rupees 2 Crore per annum exclusively in said maintenance trade. The firm should be registered or having branch office in the NCR of Delhi. Proprietary firms/ partnership firms will not be eligible.
- 2) The firm must have previous experience of maintenance of Computer Hardware (Sun Servers V890, PC, Switches), LAN (including Networking Equipments) and System Software etc. in offices & organizations of the Central Government and/ or public sector Undertakings of the Govt. of India. (certificates from at least three such offices/ organizations where the firm is presently holding AMC indicating satisfactory performance/ service providing by the firm have to be furnished along with proof of holding AMC in that office / organization as on date. The certificate should indicate the make/ brands of equipments (name of manufacturer of equipments) maintained by the firm holding AMC in that office/organization. This Centre would be free to verify such certificates from the concerned office/organization, if required.

- 3) The firm must have expertise in preventive on-site maintenance and repair of sun servers, stand-alone computers, all type of printers, scanners, laptops, projectors, associated peripherals, network components etc. and System Software particularly items mentioned at Annexure-I.
- 4) The firm also must have expertise in LAN administration Services including remedial steps for the upkeep of the entire Network with the optimum level performance by fine tuning various parameters of different S/W and H/W.
- 5) The firm must be registered with the Delhi Sales Tax Department for Works Contract Tax (certificates of registration have to be provided to this Centre)
- 6) The firm must have duly allotted PAN and also TAN (allotted by the Delhi Sales Tax Department for works contract tax). These numbers must be printed on the bills submitted by the firm for payment.
- 7) Authenticated copies of income Tax Returns filed in the last three years have to be furnished i.e 2007-08, 2008-09, 2009-10

IF A FIRM FILING QUOTATION DOES NOT FULFIL ALL OR ANY OF THE ABOVE ELIGIBILITY CONDITIONS MENTIONED ABOVE, THE QUOTATION OF THE FIRM IS LIABLE TO BE REJECTED.

Scope of the work for which quotations are being invited:

Comprehensive maintenance of Computer Hardware (Sun Servers V890, PCs, Switches), LAN (including Networking Equipments) and System Software etc installed in Computer Centre, Ministry of Statistics and Programme Implementation, East Block-10, R. K. Puram. New Delhi – 110066 (list of items to be covered under the AMC Annexed at Annexure-I).

B) Terms and conditions of the Comprehensive Annual Maintenance Contract (AMC) for which quotations are being invited:

- The period of contract shall initially be for one year from the date of commencement of the contract. However, the contract can be terminated at any time during the period of contract after giving notice of 15 days, if the firm does not render the services satisfactorily or parts/spares provided by the firm are found sub-standard of any other reasons as computer Centre, Ministry of Statistics and Programme Implementation may deem proper. It will also be open to the Computer Centre, M/o Statistics and Programme Implementation to extend the term of the agreement beyond for a further period of two years, if required.
- 2) The rates quoted will remain in force for the full period of the contract. No demand for revision of rates on any account shall be entertained during the contract period.
- 3) The firm has to provide services in Computer Centre M/o Statistics and Programme implementation East Block- 10, R. K. Puram, New Delhi-110066.

- The firm has to make provision for deployment of a qualified Resident Engineer(s) for 24 hrs without any holiday. Qualification of the Resident Engineer(s) should be a Diploma in Engineering/ Computer Science or Hardware along with CCNA/ MCSE certificates from recognized/ reputed institute with at least two Years experience in maintenance of hardware, software and networking.
- 5) The Resident Engineer of the firm should monitor the Server room comprises Sun Servers and Windows Server on 24 x 7 basis for environmental parameters. He will also maintain a log book cum attendance book. All complaints lodged will be entered in the log book with date and time of lodging of complaint and thereafter the date and time of attending to the complaint to the Engineer with details of repairs done to restore the maintenance to the satisfaction of the unit in-charge of the Computer Centre will be entered in the log book. Records of preventive maintenance done will also be entered in the book. Preventive maintenance which must be done at least once in a month for every machine shall include thorough cleaning, checking of hardware/software and replacement of any parts showing signs of wear and tear which if not likely to cause trouble in the functioning. The log book shall be kept in the custody of the concerned unit-in-charge in the Computer Centre who shall countersign all entries made with remarks if any.
- 6) If complaint is reported before 5.00 P.M. it will have to be attended on the same day, and if complaint is reported after 5.00 P.M., then complaint should be attended preferably on the same day, failing which on the next day before 11.00 A.M. As far as possible, the repairs would be carried out on-site itself. If it is found that repair is further time-consuming, the firm shall provide a similar stand-by machine of matching specifications so that the work of this Centre is not hampered or delayed. If, however, the firm fails to repair or provide a standby by the day following the day on which the complaint is lodged, then a penalty of Rs.5000/- for SUN Server, Rs. 1000/- for other server as well line printer, Rs. 500/- for other machines as well as System Software per day will be charged per machine. It may be noted that in case of intermittent failures and repetitive problems due to improper diagnosis or repair, the system will be treated as continuously down.
- 7) It shall be the onus of the firm to ensure that the Resident Engineer(s) is equipped with mobile phone so as to enable this Office to contract the Engineer(s) immediately.
- 8) It shall be the onus of the firm to provide necessary maintenance support for VIRUS free computer environment in the Centre and in upgrading the software, as and when necessary. Anti-virus software will, however, be provided by the Centre.
- 9) The firm shall maintain the equipments as per manufacturers' guidelines and shall use standard components for replacement. In case of any instance of sub-standard repair/replacement of parts used by the firm, it may lead to cancellation of the contract and other legal action may be taken against the firm, if required.
- 10) The Computer Centre shall not be liable to make payment over and above the comprehensive maintenance cost, in any case. All types of repair/replacement of spare parts shall be covered under the comprehensive maintenance contract, except the Force Majeure conditions which includes only fire, theft, natural calamities, deliberate damage/tampering etc.

- 11) Maintenance charges under the AMC shall not include the cost of consumables and supply items such as; ribbons, media like magnetic tapes, cartridges, printer bands and computer stationery. In case of Laser Printers, the maintenance charges under the AMC shall include all parts including Fuser Assemblies, Fuser Units and Teflon sheets. However, the cost of Toner cartridge of Laser Printer will not be included in the AMC.
- 12) No advance payment shall be made. Payment of maintenance shall be made on quarterly basis i.e. after completion of every quarter of maintenance by the firm. For making the payment, the firm will have to attach with their quarterly bill a report of 'satisfactory service' from the Unit under whose control the hardware/software is working/installed. The bill submitted by the firm for quarterly payment must bear PAN and also TIN allotted by the Delhi Sales Tax Department for works contract tax.
- 13) It may also be noted that in case of the firm with whom the contract has been entered into, backs out in mid-year without any explicit consent of Computer Centre, the firm shall be liable to recovery at higher rates vis-à-vis those contracted with it, which may have to be incurred by the Computer Centre on maintenance for the balance period of contract through alternative means. Further, the act of backing out will automatically debar the firm from any further dealing with Computer Centre, Ministry of Statistics and Programme Implementation.
- 14) This Centre shall have the right to include on pro-rata basis in the AMC any new equipment on the expiry of its warranty at the rate of contract for that equipment in the AMC.
- 15) It shall be the responsibility of the firm entering the contract not only to make the items under AMC work satisfactorily throughout the contract period but also to hand over the items under AMC to the Computer Centre, Ministry of Statistics and Programme Implementation, East Block-10, R.K. Puram, New Delhi-66 in working condition on expiry of the contract.
- 16) The firm to whom the AMC would be granted shall be required to submit a Performance Security in the form of a Bank Guarantee of an amount of at least 10% of the total contractual amount with the Computer Centre, Ministry of Statistics and Programme Implementation. The Bank Guarantee should be in favour of Pay & Accounts Officer, Ministry of Statistics and Programme Implementation and should remain valid at least for a period of sixty days beyond the date of expiry of the contractual period. The firm shall be required to submit the performance Guarantee at the commencement of the contract. The contract shall not be valid unless the Performance Guarantee is submitted.
- 17) In case of any dispute or differences arising at any time between this Centre and the firm holding the contract, these shall be resolved in accordance with the provisions of the Indian Arbitration Act, 1940 and only courts of Delhi shall have the jurisdiction in all matters arising out of or connected with this contract, this contract is subject to law's of India alone.

The formula for determining the financial scores is the following:

Sf = $100 \times Fm/F$, in which Sf is the financial score, Fm is the lowest price and F the price of the proposal under consideration

The weights given to the technical and financial proposals are:

T = 0.70 and

P = 0.30

The lowest Financial Proposal (Fm) will be given a financial score (Sf) of 100 points. The financial scores (Sf) of the other Financial Proposals will be computed as indicated in the Tender Document. Proposals will be ranked according to their combined technical (St) and financial (Sf) scores using the weights (T = the weight given to the Technical Proposal; P = the weight given to the Financial Proposal; T + P = 1) indicated in the Tender Document: $S = St \times T\% + Sf \times P\%$. The firm achieving the highest combined technical and financial score will be invited for negotiations.

The TECHNICAL BID (Annexure-II along with EMD) and FINANCIAL BID (Annexure-III) should be sealed in two separate envelopes and these two envelopes should be placed inside the main envelope being sent to addressee. The main envelope should also be sealed.
- 2. Quotations received after due date and time mentioned above, as well as those received without separate sealed envelopes as mentioned above will not be accepted.
- 3. The centre reserves the right to reduce or increase the number of items offered for maintenance contract.
- 4. The Centre also reserves the right to reject any quotation without assigning any reason.
- 5. An Earnest Money amount of Rs.50,000/- (Rupees Fifty thousand) through a Demand Draft / Pay Order issued by a scheduled Bank in New Delhi drawn in favour of "Pay and Accounts Officer", Ministry of Statistics and Programme Implementation, Govt. of India, New Delhi must be enclosed with the Tender (Technical Bid) submitted.
